CHAIRMAN'S REPORT

I am pleased to report that Junior Golf in Glamorgan is thriving at a competitive level. However, there are some worrying aspects which I will comment upon in concluding paragraphs.

Our Coaching Structure (see page 6) continues to work, primarily through the Autumn and Winter months, to improve the golf swings of our players. As always, my thanks go to Clive Coombs and Keith Williams (both Vale of Glamorgan), John Peters (Southern Down), Peter Evans (Royal Porthcawl) and Simon Swales (Radyr) for their collective effort, which is the envy of our fellow Welsh counties and our English South-Western rivals.

Teams' Results

The **Nursery Squad** consisted of 30 youngsters aged 8 upwards. We held four very successful 9 and 10 hole stableford competitions at Llanishen, Llantrisant, Brynhill and Pyle and Kenfig. They were all well attended and the level of competition was outstanding. The Order of Merit was won by Ellis Williams (Maesteg) from Nathan Alexander (Coed-y-Mwstwr). The Under 12s County Championship was held at the Vale of Glamorgan and once again, although the weather was poor, the enthusiasm and commitment of the boys was undiminished. The winner was Thomas Savill of Glamorganshire with an excellent gross score of 22 points over 9 holes.

My thanks go to Matthew Peet for building on the work done by Mal Roberts and taking the Nursery Squad to a higher level of achievement.

After an encouraging renaissance in 2013, the **Under 14s** Team really blossomed last year. The season began with a 'friendly' match against Worcestershire at Halesowen Golf Club in May. We were 3½ - 1½ matches up after the morning foursomes but significantly won the singles 10 - 0 (an unprecedented feat!) for an overall 13½ - 1½ victory. This set the tone: Somerset were swept aside 12 - 3 at Llanishen, but in a rain-affected match against Wiltshire at St Mary's we were actually 3 - 2 down after the foursomes and unable to deploy our singles' strength because the match was cancelled. The fourth match of the season was against Gloucestershire away at Shirehampton and the result was an outstanding victory for Glamorgan 12 - 3. Finally, in a singles only match, we defeated Dyfed 6 - 2 at Glyn Abbey in September.

The success of the Under 14s suggests that the introduction of the Nursery Squad four years ago is producing a rich harvest of talent. Simon Swales, the professional at Radyr Golf Club, attended three home matches and he was impressed with the level of our players' golf swings.

The Under 14s Order of Merit comprised the following events: the Spring Meeting at Swansea Bay; Open Days at Neath, the Grove and Glamorganshire; the Ben Williams Trophy at Whitchurch; and culminated in a 36 hole U14 County Championship at the Vale of Glamorgan. Once again the weather intervened and the Championship was decided over

18 holes. The winner was Jack Thomas (The Gower) with Sam Mayer (Cardiff) winning the Order of Merit.

My thanks go to David Watkins, who did a superb job as the Under 14s Team Manager. He has 'transferred' to the Under 16s, and I am sure we all wish Roger Chaffey from Caerphilly, who has the unenviable task of replacing and emulating him, every success.

The **Under 16s** Team's season began with a disappointing 10 - 5 loss to Worcestershire at Hagley Park in May. This was followed by an improved performance but another defeat to Wiltshire at Glamorganshire, albeit narrowly, 8 - 7. Thereafter results improved considerably with wins against Somerset, Gwent and Gloucestershire to give us 3 match points and 33 game points, meaning an exact tie with Wiltshire who, of course, had beaten us. Consequently we failed to win the Channel League by the narrowest of margins.

Martin Price, the Under 16s Team Manager, was delighted with the manner in which the boys transformed their season and is looking forward to 2015 with great confidence.

Our improvement continued at the SWBGA U15 / U16 inter-county tournament where we were the overall victors. Jamie Pickering (Royal Porthcawl) had the best individual score of 72 at Glyn Abbey Golf Club. Unfortunately, the 'double' escaped us when we came second to Flintshire in the Welsh Boys Under 16s Inter Counties at Haverfordwest in August.

In 2014 we introduced an Under 16 Order of Merit Trophy for the first time. This consisted of the Spring Meeting and Junior County Championship plus open meetings at Neath, The Grove, Glamorganshire and Whitchurch Golf Clubs. Joe Lukaris (Creigiau) was the clear winner with emphatic victories in four of the six events. Joe made great strides in 2014 and is clearly 'one to watch'.

On the national stage, Jamie Pickering made his mark: he won the Welsh Boys Under 15 Championship at the North Wales Golf Club and went on to reach the semi-finals of the Welsh Boys at Wenvoe Castle. Jamie, Harry Frazer (Pennard) and Hari Pachu (Gower) all represented Wales in various competitions through the season.

The **Under 18s** Team improved on the disappointing 2013 season. There were Channel League victories against Somerset 9 - 6 and Gwent 8 - 7 and a halved match against Gloucestershire but a narrow loss to Wiltshire 8 - 7. This meant that we came joint second to Wiltshire in the league.

There was similar evidence of improvement in the Severnside Tournament which returned to Ross on Wye Golf Club in late August. We defeated Worcestershire 5 - 2 and Gwent 4 - 3 but lost to Gloucestershire 4½ - 2½. Consequently, we finished joint first in terms of team victories, but fell back to 3rd in the final table on the basis of individual matches won! On balance therefore, the Under 18s made significant progress and I thank Steve Joseph and John King for the effort they put in.

Five of our players represented Wales in 2014: Tim Harry (Vale of Glamorgan), Kyle Harman (Radyr), Rhys Jones (Mountain Ash), Robert Evans (Vale of Glamorgan) and Tom Davies (Radyr). Kyle, Rhys and Tim played in the Junior Home Internationals at Western Gailes in August and contributed to a much improved performance. Tim reached the semi-finals of the British Boys and was selected to play for Great Britain and Ireland against Europe in the Jacques Leglise Trophy, where he contributed 1½ points in a 12½ - 11½ victory.

Individual Performances

The Spring Meeting was held at Swansea Bay in April. The U18 players started first and had the worst of the weather. The best gross in this category was won by Jordan Golley (Clyne) with a 75 but it was the U16 winner, Joe Lukaris, who triumphed overall with a round of 74.

The County Junior Championship returned to Morlais Castle in July and a two round total of 148 strokes saw Rhys Jones become champion, one shot ahead of Daniel Pickering (Royal Porthcawl).

The first sixteen players were eligible to qualify for the inaugural County Junior Match Play Championship, which was played at Caerphilly Golf Club in July. The whole occasion was a magnificent success with some thrilling 'head to head' matches. In the final Oliver Brown (Vale of Glamorgan) defeated Harry Frazer (Pennard) by one hole and by doing so wrote his name into the record books as the first Glamorgan Junior Match Play Champion.

At the beginning of 2014, because of declining participation in junior golf particularly in the West of the county, it was decided to reorganise the County Junior Leagues. I have to report that this initiative was not successful and failed to galvanise interest in playing inter-club matches. Quite simply, too many teams failed to fulfil their fixtures. The background to this phenomenon is lack of numbers: since 2009, there has been a 40% decline in the number of youngsters playing golf in the County. Only 3 years ago we had almost 150 applications for County Coaching and had to reject some of them; by October 2014 we had only 82 applications for coaching. This problem is not unique to Glamorgan; it is replicated in every county in England as well. There is no doubt that participation in British golf is declining rapidly, with 890,000 having played once a week in 2005 compared to 730,000 in 2014. In the key 16 - 25 age bracket the numbers dropped from 52,000 to 38,000 in the past year. In that context the R and A's decision to abandon the terrestrial audience for the Open Championship from 2017 might appear to be madness. I have no idea how to provide a solution, but it is a pressing issue which needs to be debated within our clubs.

However, none of this is to decry the achievement of Maesteg Golf Club who, in a 'golden' week last October, won the Welsh Junior Club Team Championship at Builth Wells and followed this up within 24 hours by winning the Glamorgan Junior title when they defeated Pontypridd at Royal Porthcawl. This is a magnificent achievement by a club which has invested so much in its juniors under the leadership of Robert Lewis.

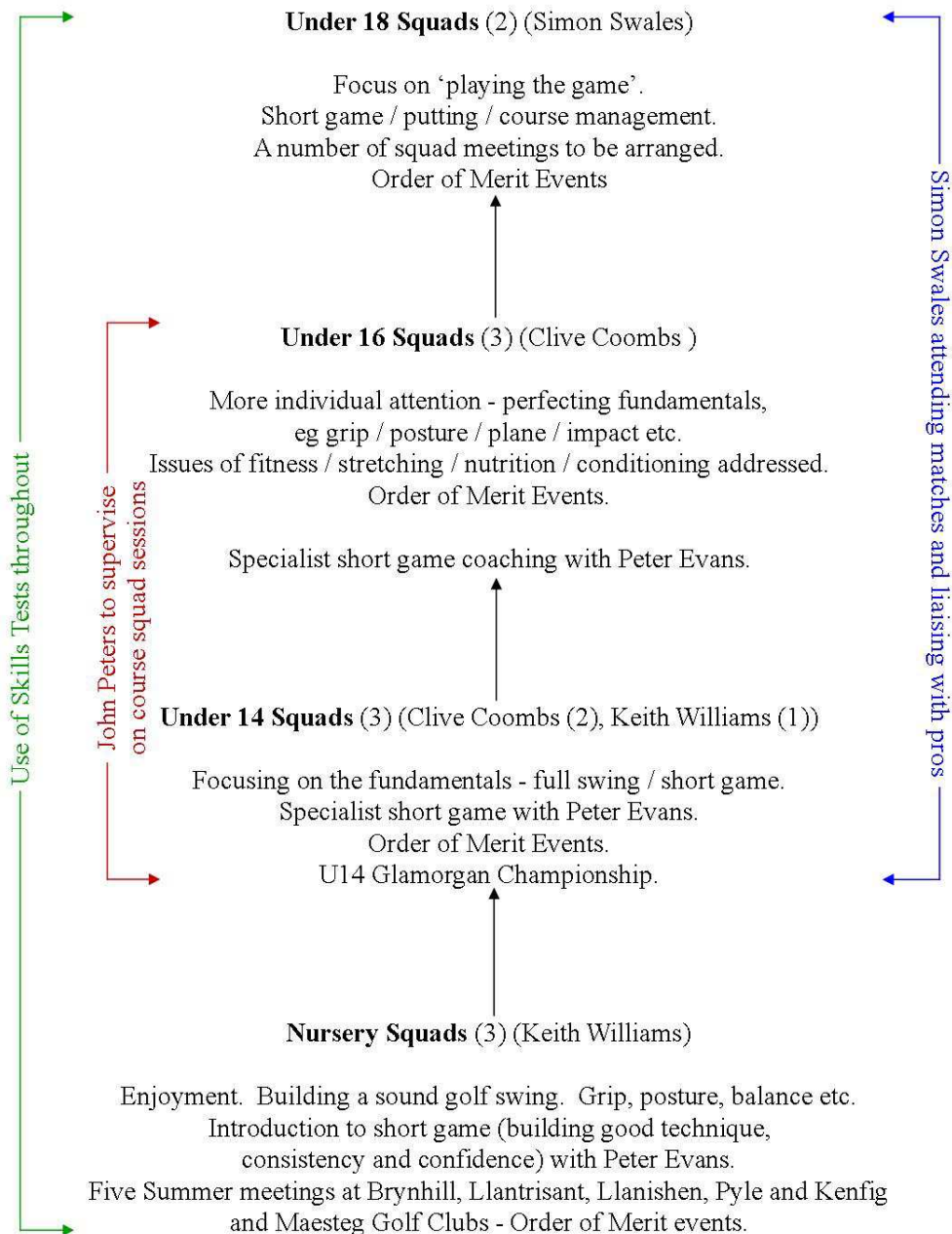
I would like to thank all the members of the Glamorgan Juniors' Committee for their continued unflinching support in the past year. It would be invidious to name them individually but each one deserves your thanks. A particular 'thank you' to Mal Roberts, who has served this county with distinction for almost 20 years, most recently as Juniors' Secretary. Mal has decided to retire but I expect him to turn up at matches as and when he wishes. My thanks to the clubs who allow us to use their courses and the patience of club members, almost all of whom appreciate the value of junior golf.

Let me finish with the 'shot of the year'. In late July 2014 the Under 16s played Somerset at Mendip Spring. On the 7th hole, a par 5, Harry Frazer, using his range finder, had 295 yards to the pin. Lovely day, dead calm, no wind. He used a 2 iron, the ball took off like a tracer shell and finished up just over the green - more than 300 yards away. I have never seen anything like it!

JUNIORS' LEAGUE RULES 2015

RULES APPLICABLE TO INTER-CLUB TOURNAMENT FOR JUNIOR TEAM AND EAST v WEST MATCHES. ALL MATCHES MUST BE PLAYED IN ACCORDANCE WITH THESE RULES.

AS AMENDED FEBRUARY 2015

DEFINITION A junior shall be a member of an affiliated club who has not reached the age of 18 years at 0.00 hours on January 1st of the year of the tournament. The player must have a current (not suspended) CONGU® Handicap.

- 1 Eligible Clubs** The Tournament shall be played between Clubs affiliated to the Glamorgan County Golf Union and such other clubs as may be admitted at the discretion of the County Junior Executive Committee (subsequently the Committee). A Club may only enter one team.
- 2 Players** A player, being a junior as defined, may only represent the affiliated Club that is his / her **home club** for handicap (as defined in the CONGU® UHS System). Having represented that Club in the Inter-Club Tournament he / she shall not be eligible to play for another Club in the same Tournament.
- 3 Rules of Golf** The matches in the Tournament shall be played according to the Rules of Golf, as approved by the Royal & Ancient Rules Limited, and the Local Rules and By-Laws of the Club on whose course the match is being played.
- 4 Leagues** The Committee shall allocate and divide the Club teams into Areas and as many Leagues as appropriate. Teams shall play home and away matches against all other Clubs in their League.
- 5 Period and Format** The League Tournament shall run from March 1 to August 31. Each match will take the form of three foursomes games and one reserve foursomes game. The games will be played off handicap from the men's medal tees. The handicap allowance will be half the difference between the combined handicaps. The maximum handicap allowance permitted for each player is 18. Players with higher handicaps may compete but off 18. Girls' handicaps shall be adjusted where appropriate according to the CONGU system in use at the time. (This adjustment may mean a girl off 18 having a higher adjusted handicap in the match. Girls off more than 18 must be reduced to 18 and then any SSS adjustment added.) Pairings may be selected in any combination but the playing order shall be the lowest aggregate handicap first and so on. The reserve match is excluded from this requirement, and a maximum handicap of 24 will apply **in this match only**.
- 6 Scoring of Results** All League matches, area play-off matches, the League final and the East v West match shall be decided by match play. Strokes shall be taken according to the men's card. In League matches teams score two points for each game won, one point for each halved game, with tied matches (3-3) allowed. In all other matches a straight overall win / loss shall be recorded as the result (with ties resolved as in 7 below). Individual game points do not count.

- 7 Resolution of Ties** On completion of the League Tournament, in the area play-offs and in the League final, ties shall be resolved by the result(s) of the reserve game(s), scored $\frac{1}{2}$ point for a win and a $\frac{1}{4}$ point for a halved game. In completed Leagues, where a tie is not resolved by the total points gained by the reserves of the teams involved, the results of the matches between the tying teams shall be used and if a tie still persists, lots shall be drawn. In play-offs and the League final, ties that are not resolved by the reserve game, “holes up” shall be used, including the reserve match. If the tie is still not resolved the top pair from each team shall play a “sudden death” play-off.
- 8 Arranging Fixtures** The date and time when a match is to be played shall be mutually agreed between the Club Junior Organisers. Failing such an agreement, a match shall be played on a date to be decided by the Committee, who will give 10 days’ notice of the date to the respective Club Junior Organisers, unless the closing date in 5 above dictates otherwise.
- 9 Match Results** The Junior Organiser of the **winning team** is responsible for completing fully and submitting the pro-forma result cards. Sending the results by e-mail is also acceptable. In the case of a halved match the **home team organiser** is responsible. Individual handicaps must be recorded on the result cards. Girl competitors shall be clearly identified on the card as (F). The result shall be posted to the Area Junior League Secretary within 48 hours of the match being completed.
- 10 Electronic DMDs** The use of such devices is allowed if the home team’s club, or the club of the course on which the match is being played, has introduced a Local Rule to that effect.
Note: If a DMD is used when no such Local Rule is in force or if the device used is designed to gauge or measure other conditions that might affect play (gradient, windspeed, temperature etc.) the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional function is used.
- 11 Caddies** Caddies are not allowed in team matches unless prior approval has been obtained from the Committee. Such approval will only be given in exceptional circumstances. Relatives / spectators should not act as forecaddies.
- 12 General** Relatives / spectators should maintain a reasonable distance between themselves and the players and must keep at least 20 yards **behind** play at all times.
- 13 Breach of Rules** The Committee shall adjudicate on any breach of the above rules that comes to its attention, or is reported to the Committee Chairman in writing. In all cases the Committee’s decision, ratified by the County’s Executive Committee where appropriate, shall be final.
- 14 East v West Match** This shall consist of eight games. In the event of a tie, providing weather conditions permit, each Team Captain shall nominate one player to take part in a “sudden death” play-off.

Under 14 Report

In order to try and improve on a winning formula, the Under 14s did away with the 'traditional bacon rolls' and opted for a vigorous stretching and exercise programme, followed by their own individual warm up routines before the start of the matches. In the first match away to Worcestershire, the boys almost recorded an overall perfect score, winning 13½ - 1½. They did win all 10 single matches and again we thank all at Halesowen Golf Club for the fabulous hospitality afforded to all.

The second match of the season was against Somerset at Llanishen Golf Club. Glamorgan won the morning foursomes 4 - 1, which included some impressive victories. Simon Swales followed the matches throughout the day and his advice given over lunch proved invaluable as the boys won the afternoon singles 8 - 2 to produce an overall match score 12 - 3.

The third match of the season was against Wiltshire at St Mary's Golf Club and despite completing the morning foursomes with some greens out of play, a torrential downpour with all single matches out on the course put paid to any chance of the matches being completed.

The fourth match of the season was against Gloucestershire at Shirehampton and following last year's narrow victory a tough match was anticipated. As against Somerset, the boys won the morning foursomes 4 - 1 and the afternoon singles 8 - 2 for another impressive 12 - 3 victory.

In the final match of the season at Glyn Abbey Golf Club, Dyfed were defeated in a singles-only match 6 games to 2.

The stand-out performances of the season were Sam Mayer playing the front nine at Llanishen 4 under par, Sam Mayer and Harry Watkins winning their foursomes match 5&4 and being 3 under at the time and finally Harry Watkins playing the last 5 holes in 2 under par to come from 3 down to win on the last and maintain his undefeated singles record.

Following last year's inaugural U14s Order of Merit, this year's Order of Merit was comprised of the following events: the Spring Meeting at Swansea Bay, open days at Neath, The Grove and Glamorganshire, the Ben Williams Trophy and a stand-alone 36-hole U14 County Championship at The Vale Resort. Once again the weather intervened, reducing the County Championship to an 18 hole event, which was won by Jack Thomas (Gower) with Sam Mayer (Cardiff) winning the Order of Merit.

My thanks go to Harry Evans (Royal Porthcawl) who captained the U14s last season and Malcolm Roberts, Teg Bevan, Matthew Peet and Mike Mayer for their assistance throughout the season.

Under 16 Report

The 2014 season saw the introduction of an U16s Order of Merit competition. This began with the Spring Meeting at Swansea Bay Golf Club followed by open days at Neath and The Grove, the County Championships at Morlais Castle, which carried double points, the Junior Open at Glamorganshire and the Ben Williams Trophy at Whitchurch. It was hoped to include the Junior Open at Pyle and Kenfig but it was not possible to play this event in the summer. The final Order of Merit table would be made up of the total of the competitors' best five points scores in the six OOM events.

Joe Lukaris (Creigiau) picked up the maximum 45 OOM points on offer at Swansea Bay with a score of 74. Joe was not only the leading scorer in the U16 section but was also the overall winner on the day. He then extended his lead at the top of the OOM with another maximum points score at the Neath Bell. Joe's round of 71 was good enough to beat Rowan Warren (Fairwood Park) into second place. At the Grove Junior Open it was more of the same; Joe again topped the leaderboard but this time was joined by Rowan as well as Hari Pachu (Gower) and Marcello Verma (Cottrell Park), who all carded 75s. It took a fine performance by Oly Brown (Vale Resort) in the County Championships to finally deprive Joe of the top spot in an OOM event. Only just, though! Oly scored 152 for his 36 holes with Joe joint second with Hari Pachu on 154.

So after four events the OOM was led by Joe Lukaris on 215 points followed by Rowan Warren (163), Hari Pachu (150) and Oly Brown (115). At the Glamorganshire Junior Open the form book went out of the window as Chester Morgans (Fairwood Park) produced his best round of the year with a 74 in first place as the top four in the OOM all shot scores in the eighties. However, in the final event at Whitchurch normal service was resumed with Joe picking up the top spot; he was duly presented with the inaugural U16 OOM salver by Whitchurch President Ben Williams.

This year an U18 County Matchplay Championship was played for the first time. Sixteen players from the County Strokeplay Championships qualified to play in the knockout stages at Caerphilly Golf Club. Eight of those sixteen were U16 squad members and two of those were successful in reaching the final. In a very close and entertaining match, Oly Brown eventually defeated Harry Frazer (Pennard) by one hole.

The team matches started very poorly with a weak performance against Worcestershire in a friendly match played at Hagley Golf Club. A much improved effort against Wiltshire produced an exciting finish at Glamorganshire but unfortunately we lost 8 - 7 and so our prospects of winning the Channel League looked gloomy. We then started the fightback and a significant upturn in fortune. Juniors' Chairman Roger Jones was manager for the next match against Somerset and he says that the 9 - 6 victory was purely down to improved management! He is right, of course. The team then went on to record two excellent victories, against Gwent at Creigiau in a tense finish by 8 - 7, and a 9 - 6 win over Gloucestershire completing the season.

Our 3 match points and 33 game points was an exact tie with Wiltshire, who had also lost one match. However, as they beat us in our match, they would be declared the winners of the Channel League. Or so it seemed! Gloucestershire were claiming that their match with Wiltshire was a half when Wiltshire were claiming an 8½ - 6½ win. All down to the rules regarding a match that is abandoned because of bad weather conditions - long story. At the time of writing the result is not known. If Gloucestershire v Wiltshire is declared a half then we are the Channel League winners. It matters not. The way this group of players turned our season around was a winning performance wherever we finished in the league.

Our improvement continued at the SWBGA U15 / U16 inter-county tournament where we were the overall winners. Jamie Pickering (Royal Porthcawl) had the best individual score with a 72 at Glyn Abbey Golf Club. Unfortunately, we weren't quite able to do the double with a win in the Welsh Boys U16 inter-counties where we came second to Flintshire.

On the National stage, congratulations to Jamie Pickering on winning the Welsh Boys U15 Championships at North Wales Golf Club. Jamie has had a great year. He reached the semi-finals of the Welsh Boys Championship at Wenvoe Castle, represented Wales in the U16 Quadrangular tournament in April and played against England in August. Jamie and Harry Frazer played for Wales U15 against Surrey and Jamie and Hari Pachu played for Welsh Schools versus England Schools at Conwy. Well done all.

Finally, I would like to thank Roger Jones for his assistance and support; Glamorganshire and Creigiau for hosting our home Channel League matches and all the clubs which staged our OOM events; all the parents for their understanding and patience, but most of all the boys for their continued enthusiasm and commitment to county golf. My overriding feeling at the end of the season was that it was a shame it had to end. Roll on next year ...

The U18 team Channel League results were encouraging with victories against Somerset by 9 matches to 6 and against Gwent by 8 matches to 7. The match against Gloucestershire was halved and the team was defeated by Wiltshire, the U18 Channel League Champions, by 8 matches to 7. It was a case of what might have been and the U18 team finished joint second in the U18 Channel League. It was particularly pleasing to introduce two Glamorgan U16 players into the U18 team, Harry Frazer and Jamie Pickering, who performed very well in the two matches they played. In addition, we were also able to bring in two players, Nathan Schmidtke and Matt Roberts, who had come through the U18 County Development Squad Winter Coaching in 2013 / 14. Dan Pickering also maintained his record from U16 Channel League matches in continuing to win all his Channel League singles matches.

It was also a similar scenario in the Severnside Tournament at Ross on Wye where the team defeated Worcestershire by 5 matches to 2 and Gwent by 4 matches to 3 but lost to Gloucestershire by 4½ matches to 2½ matches. 2nd July, County Junior Championship, Morlais Castle Golf Club

On a warm summer's day a strong field set out to tame Morlais Castle to claim the County Junior Champion's title. At the end of the 36 holes, Mountain Ash junior Rhys Jones took the honours with a 36 hole total of 148. Second was Royal Porthcawl's Daniel Pickering and third Neath junior Luke Colwill. The U16 Gross title went to Vale Resort's Oliver Brown with Hari Pachu (Gower) second. Jack Thomas (Gower) won the Ivor Nicholls Trophy for Best Nett 36.

The story of the morning 18 was steady rounds played by the leaders, but Neath's Luke Colwill arrived at the 14th 4 under par and walked off the green 5 over! He dropped a further shot on 18 to finish on 77. To his eternal credit, disappointed as he may have been, he headed out for the 2nd round with the same determination with which he attacked the first. Rhys Llewellyn, Daniel Pickering and Oliver Brown, an U16, led the way with 3 over par 4s but with four players within 2 shots the afternoon was set up for a close finish.

And so it proved. Rhys Llewellyn and Oliver Brown fell away slightly with 78s, the heat possibly taking its toll a little. However, Rhys Jones and Daniel Pickering were establishing a lead. After 9 holes Daniel had increased his lead over Rhys to 3, being out in 2 under 34 to Rhys' level par 36. Both players dropped shots early in the back 9, and arriving at the 16th tee Daniel had kept the margin at 3. However a bogey, par double bogey finish was to prove costly, Rhys finishing birdie, par par to take the Championship by one stroke.

Luke Colwill, meanwhile, showed what might have been with a birdie 4 on 16 for a 75 and a two round total of 152, finishing third.

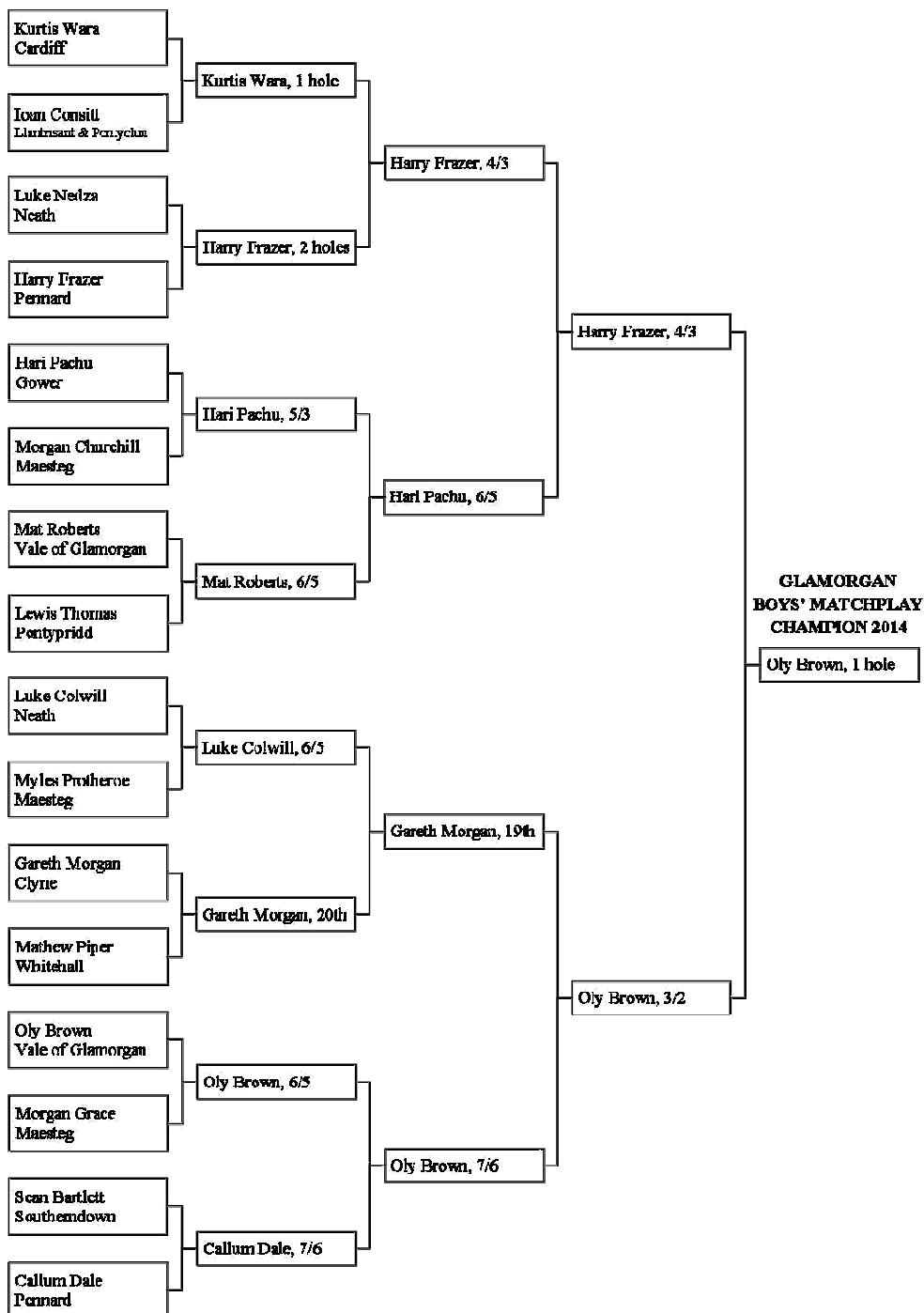

CHILDREN IN GOLF

CHILD PROTECTION STATEMENT AND POLICY

The Glamorgan County Golf Union has very carefully considered its responsibilities to the children participating in golf events they arrange, and has produced the following Policy Document. The document supported by underpinning Procedure Documents sets out the Standards the County wish to uphold in safeguarding the welfare of children committed to our care when they participate in golf events organized on their behalf. This Document recognizes the policies set out in Guidelines for Safeguarding Children in Golf (the “Guidelines”) prepared by the various National Organizations.

POLICY STATEMENT

The Glamorgan County Golf Union recognise that children have a unalienable right to protection and have their particular needs understood and addressed. They acknowledge its duty of care to safeguard the welfare of all children (defined as any young person under the age of 18) involved in golf events they organise. It is the responsibility of the Executive Committee to ensure that the Policies reflect the spirit and intent of the Guidelines in respect of all occasions where children are in their care. Further that all persons acting on their behalf that assist in the organisation and running events are fully aware of the Policies and their implications.

Policy Aims

- To provide children with appropriate safety and protection whilst in our care and also help them to enjoy their experience of the sport.
- To reassure parents that their children will receive the best practicable care possible whilst participating in County activities.
- To provide support to staff and volunteers to make informed and confident responses to specific child protection issues and to fulfil their roles effectively.

KEY PRINCIPLES

- The welfare of children is paramount.
- All children within Golf, regardless of age, gender, ability, disability, race, religious belief or sexual orientation, have the right to be protected from abuse.
- All suspicions and allegations of abuse and poor practice will be taken seriously and responded to swiftly and appropriately.
- All children have the right to be safe and to be treated with dignity and respect at all times.
- All staff and volunteers working in golf have a responsibility to report concerns to the designated County Welfare Officer.
- All County Officials, volunteers, coaches and referees need to understand their role and responsibility with regard to the duty of care and protection of children and young people.

- Individuals will receive support through education and training to be aware of and understand best practice and how to manage any welfare or child protection issues that may come to light.
- Where necessary we will work in partnership with parents to review and implement child protection and welfare procedures.

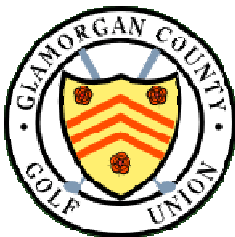
Our policy and procedures are based on the above principles and UK and international legislation and government guidance and take the following into consideration:

- The Children Act 1989 and 2004.
- The Data Protection Act 1994 & 1998.
- The Police Act 1997.
- The Human Rights Act 1998.
- The Protection of Children Act 1999.
- Caring for the young and vulnerable – Home Office Guidance for preventing the abuse of trust 1999.
- The Criminal and Court Services Act 2000.
- What to do if you are worried a child is being abused 2005.
- Working Together to Safeguard Children 2006.
- The UN Convention on the Rights of the Child.
- Any subsequent legislation relating to child protection would implicitly be incorporated into this document.

Responsibilities & Communication

- Our Child Protection Policy will be available to all members of the County Organisations, parents, staff, volunteers and participants via the Organisations' Websites.
- The Policy will be reviewed every three years by the Executive Committees, and amended as appropriate. Changes in Legislation and recommended best practices from National governing bodies will be incorporated where appropriate.
- The Executive Committees have responsibility for ensuring that the policy and procedures are implemented, including taking any appropriate disciplinary action necessary.
- The designated County Welfare Officer has responsibility for responding to any allegations, concerns or child protection incidents, passing information to the appropriate National Governing Body Lead Child Protection Officer and informing the appropriate County Officers.
- Parents have a responsibility to work together with the County Organisations in implementing procedures and providing their children with the necessary information to safeguard themselves.
